## Emergency Solutions Grant (ESG)

### Letter of Intent

The Central Sierra Continuum of Care (CSCoC) is seeking Letters of Intent of requests for funding for the 2023 round of ESG funds for our region.

Non-Competitive funding is done by formula and does not require a request for funding.

Competitive funding does require our CSCoC provide the State of California with up to three (3) applications for funding. We are not allowed to submit more than three (3). These applications may or may not be funded, but we are only allowed up to three (3).

In the past we have not had more than three (3) entities apply in the Competitive funding. These Letters of Intent will allow our CSCoC to determine if we have more than three (3) entities applying for ESG funding. If we have more than three (3) we will utilize our formal ESG Application and ESG Scoring Tool. This process will require an Application be submitted by a specific date; a review and rank allocation team review and rank the applications and send their recommendations to the CSCoC Governing Board for approval of the three (3) competitive applications to be submitted for ESG funding for 2023.

ESG Competitive funding may be used for the following: Emergency Shelters and/or Rapid Rehousing. The Competitive funding is usually capped at \$200,000 but we do not have the 2023 NOFO yet. HMIS and HP capped at 10%.

Entities funded must participate in the CSCoC Coordinated Entry System (CES) and the Homeless Management Information System (HMIS), and comply with ESG/CSCoC Written Standards, Emergency Shelter Policies and Procedures, and utilize the ESG rental packets. Funded entities must meet all threshold requirements stated in NOFO and provide a one-to-one match for every dollar of ESG funding awarded.

Attached is last year's NOFO for reference. We do not have the NOFO for 2023 yet.
