Hello all:

We have had a busy couple of days with our HUD Special Committee trying to determine if we want to move forward with the CSCoC applying for one or both of the funding opportunities. There was a lot of discussion regarding eligible costs which resulted in a final determination and recommendation by the Committee to the Governing Board for this Special meeting.

The formula for funding was agreed to by the Committee and is their recommendation to the Governing Board for approval (see excel spreadsheet attached)

The eligible costs were also agree to by the Committee and is their recommendation to the Governing Board for approval (see Letter of Intent)

The process being recommended is:

July 11th: publish on website and to full membership the Letter of Intent with the HUD NOFO for reference

July 14th: Letters of Intent due to the CSCoC

On or before August 17th Projects enter information into e-snaps, downloaded and copy to Allocation Team

August 28th (regular monthly Governing Board meeting) or Special Meeting September (no later than September 20th) Governing Board approve Priority Listing

October 20th full applications (two 2) with Priority Listings submitted in e-snaps
